# United Nations launches a Women Enterprise Recovery Fund

ESCAP and the United Nations Capital Development Fund (UNCDF), with support from the Dutch Entrepreneurial Development Bank (FMO), the Government of Canada, and Visa Inc. on 8 January 2021 launched a 'Women Enterprise Recovery Fund: Promoting and Upscaling Digital Solutions for Enhancing Women Enterprise Growth and Resilience'. Through the Fund, the partners will support innovative business solutions that address the constraints faced by women enterprises in South and South-East Asia, providing up to US\$ 50,000 in co-funding, along with technical assistance through partner networks. # Call for proposals for side events at APFSD

The 8<sup>th</sup> Asia-Pacific Forum on Sustainable Development (APFSD) will be held in hybrid mode on 23-26 March under the theme *"Sustainable and resilient recovery from the COVID-19 pandemic in Asia and the Pacific"*. Side events to the APFSD can be organized and sponsored by member States, the UN system, other intergovernmental organizations, accredited CSOs or other stakeholders. Held outside the official programme, they provide an opportunity to discuss the theme of the 2021 APFSD *"Sustainable and resilient recovery from the COVID-19 pandemic in Asia and the Pacific"*, or one (or more) of the SDGs under review, or to deepen discussions on Voluntary National Reviews, and to share good practices, identify new and emerging issues, and spread greater awareness of the 2030 Agenda and the SDGs. #### WTO: package of declarations and recommendations adopted to help small businesses trade globally

The WTO Informal Working Group on Micro, Small and Medium-sized Enterprises (MSMEs) officially adopted at its meeting on 11 December a package of six recommendations and declarations aimed at addressing challenges smaller businesses face when they trade internationally. The package was presented to all WTO members at a meeting of Heads of Delegation on 14 December.

### 21 January 2021: Launch of ESCAP's Trade Intelligence and Negotiation Advisor (TINA) 3.0

ESCAP's Trade Intelligence and Negotiation Advisor, TINA (<u>https://tina.trade</u>) is an online tool designed to assist trade policymakers, as well as researchers and consultants supporting them, to carry out many of the analytical tasks commonly conducted in preparation for negotiation. These tasks require specialized analytical and data management skills and are time consuming when performed manually. TINA automates such tasks, enabling countries with limited resources to benefit from the same level of preparation as those afforded by larger economies. TINA has been developed in close consultation with current and former members of trade negotiation teams throughout Asia and the Pacific, developed by a team of trade economists, coders and web application programmers using state of the art methodologies and technologies. It has most recently been used, at the request of the Government of Bangladesh, to assist with the feasibility study of a trade agreement between Bangladesh and India.

# 25-26 January 2021: Sixth Meeting of the Interim Intergovernmental Steering Group on Cross-Border Paperless Trade Facilitation

The meeting will be held on 25 (13:00 – 16:00) and 26 (13:00 – 14:30) January 2021, Bangkok time. The interim intergovernmental steering group on cross-border paperless trade facilitation was established following ESCAP Commission Resolution 70/6 adopted in 2014. Following finalization of the treaty text of the Framework Agreement on Facilitation of Cross-Border Paperless Trade in Asia and the Pacific in 2016, the steering group now focuses on preparation of a draft implementation roadmap of the agreement and related supporting documents. <u>https://www.unescap.org/events/sixth-meeting-interim-intergovernmental-steering-group-cross-border-paperless-trade#</u>

# 27-29 January 2021: Committee on Trade and Investment, Seventh Session

The seventh session of the Committee on Trade and Investment of ESCAP will be held daily from 10:30 to 13:30 on 27 and 28 January with the adoption of the report on 29 January from 13:30 to 16:30. The Committee will review recent trends and developments in trade and investment in Asia and the Pacific including impact of rising protectionism and COVID-19 pandemic; discuss promoting inward and outward foreign direct investment in the post-COVID-19 era; discuss the work of the secretariat and associated results and priorities pertaining to trade and investment under the subprogramme on trade, investment and innovation; and consider the programme plan for the 2022 annual budget on trade and investment. The objectives of the seventh session of the Committee are two-fold: (1) to review and discuss relevant issues on trade, investment and regional integration especially in the context of COVID-19 recovery and building back better; and (2) provide guidance and propose areas for regional cooperation to contribute to enhancing resilience of trade and investment in the region. # 23-24 February 2021: 10th meeting of the Asia-Pacific Foreign Direct Investment (FDI) Network

The Network was established in 2011 as a mechanism for knowledge sharing among FDI policy makers from Least Developed and Landlocked Developing Countries of the Asia-Pacific region and was expanded in 2015 to include all ESCAP member and associate member States. Each year, the network meets to discuss topical FDI issues and increase their knowledge through exchange of experiences and interaction with FDI experts.
