Recent ESBN activities

Executive Council of the ESBN, 3rd meeting

On 15 May 2020 the Executive Council of the ESBN held its third meeting to discuss ESBN direction, including potential roles of the ESBN in relation to COVID-19 and sustainable oceans/plastics. The EC adopted the following decisions:

- 1) ESBN membership shall be company or organization based.
- 2) To strengthen the sustainability credentials of the network and grow it into a network of corporate sustainability leaders in the region, consideration for ESBN membership will be contingent on a requirement to: (a) sign up to implement at least one of the following internationally recognized principles and standards for responsible and sustainable business (Global Compact or similar), (b) measure and show the company progress on sustainability issues in a transparent and verifiable manner, by issuing an annual sustainability report in accordance with reporting standards and guidance of the UN Global Compact, GRI, the Task Force on Climate Related Disclosures (TCFD), CDP, International Integrated Reporting Council (IIRC), or equivalent.
- 3) ESBN members should also strive lead on climate action by performing climate-based reporting and target setting, preferably by committing to set science-based emission reduction targets in line with Science-based Target Initiative¹ and the Business Ambition for 1.5°C.²
- 4) Taskforces will be refocused from generic to specific (issue-based), outcome oriented and timebound, with clear TOR, deliverables and indicators of success, and objectives and initiatives aligned with the ESCAP work programme.

Asia-Pacific Forum on Sustainable Development

9-11 June 2020 (10.00-16.30 Bangkok time daily + side-events on 12 June) United Nations Virtual Forum on Responsible Business and Human Rights (online)

We encourage ESBN members to attend the Asia-Pacific focused *United Nations Virtual Forum on Responsible Business and Human Rights forum: New Challenges, New Approaches,* to hear discussions on the state of play of responsible business in the region. Organized by ESCAP, UNDP, ILO, UNICEF, UN Women and the UN Working Group on Business and Human Rights, the forum will for the first time be held fully virtually. Over 4700 participants have already signed up to participate in the 20 sessions and 18 side-events of the Forum. The Forum will discuss drivers for and challenges in promoting responsible business conduct in Asia and the Pacific, especially as the region is entering the COVID-19 recovery phase, share best practices by business, and explore how governments and business can collaborate on post-COVID-19 recovery, building back stronger, more sustainable, more resilient and with a focus on responsible business practices. Changing Sails: Accelerating Regional Actions for Sustainable Oceans in Asia and the Pacific (13 May 2020)

The ocean and its resources are the lifelines of Asia and the Pacific. As a resource for the economy, livelihoods and identity for coastal communities, the condition of the ocean is inextricably linked to the pathways of sustainable development in Asia and the Pacific.

Produced in line with the 76th Session of the Economic and Social Commission for Asia and the Pacific, the theme study Changing Sails: Accelerating Regional Actions for Sustainable Oceans in Asia and the Pacific explores the key areas around which regional platforms can rally interdisciplinary and cross-sectoral solutions for the ocean. It highlights the lack of data and statistics on the ocean, the growing demand for moving towards inclusive and green maritime shipping, deteriorating fish stocks and gaps in fisheries management and the mounting pressure of marine plastic pollution.

Fast-tracking the SDGs: Driving Asia-Pacific Transformations (20 May 2020)

Reflecting on the theme of the7th Asia-Pacific Forum on Sustainable Development, this report informs regional and global dialogue on sustainable development as well as national and regional implementation of the 2030 Agenda for Sustainable Development. Digital Trade Integration in Preferential Trade Agreements (May 2020)

Some recent PTAs contain ambitious provisions to reduce regulatory barriers in digital trade and facilitate cross-border data flows. However, most PTAs fail to holistically support the five pillars of digital trade integration and are particularly deficient in supporting digital development and inclusion, incorporating adequate digital trade facilitation measures, and facilitating meaningful international regulatory cooperation. This working paper examines the trade impacts of two external shocks – the US China trade war and the COVID-19 pandemic - from the perspective of the healthcare sector.
