### 6 May 2022: Virtual launch of the Finance Flows' Sustainable Banking Academy

To assist the shift of the banking sector towards sustainable outcomes, a group of agencies comprised of the Association of Development Finance Institutions in Asia and Pacific (ADFIAP), Global Reporting Initiative (GRI), United Nations Economic and Social Commission for Asia and the Pacific (ESCAP), United Nations Environment Program Finance Initiative (UNEP FI) and the World Wide Fund for Nature (WWF) have launched the Finance Flows' Sustainable Banking Academy. The Academy's e-learning course content includes 5 to 10 hours of self-paced and tailored content for Southeast Asian banking sector professionals and provides participants with a certification. # 19 May 2022: High-Level Regional Roundtable on Investment Facilitation for Development: How Asian and Pacific Economies Will Benefit

The Roundtable, co-organized by the International Trade Centre (ITC), the German Development Institute/Deutsches Institut für Entwicklungspolitik (DIE), ESCAP and the World Economic Forum (WEF), has offered a platform for a strategic exchange among government officials on the World Trade Organisation (WTO) negotiations on an Investment Facilitation for Development (IFD) Agreement, launched in September 2020 after over two years of preparatory discussions. ESCAP joined with UNCTAD to launch the recommendations, which have arisen from a series of projects in partnership between UNCTAD and ESCAP, in an online meeting.
