25 October 2022: Taxation of the Digital Economy in Asia and the Pacific

The emergence of the digital economy has challenged the core of existing international taxation norms and left growing shares of the economy untaxed or undertaxed. The international community has made encouraging progress in taxing the digital economy at both national and international levels. However, significant gaps remain. Smaller and poorer developing countries, in particular, are still marginalized in international taxation reforms and lack effective but easy-to-use tax options for tapping into the digital economy revenue base. The workshop serves to better inform governments of Asia-Pacific developing countries in their exploration of policy options for taxing the digital economy and solicit country feedbacks on how the United Nations can better support them on this front. 26 October 2022: The Digitalization of Tax Administrations in Asia and the Pacific

Recent innovations in tax administration include digitalization, automating tax reporting and compliance processes, which can benefit from recent technological developments like AI, machine learning, and customer assistance chatbots. This workshop aims to share information and experiences among Asia-Pacific tax administration departments on the current level of digitalization to identify obstacles and solutions. Focus areas of discussion will revolve around ICT technologies such as e-filing and e-payments to help collect taxes, tax compliance digital tools, big data analytics, AI, and machine learning applied to tax administration. The workshop will also review good practices in using e-taxation tools in the region and will help identify activities governments may undertake to improve tax compliance using e-taxation technologies. 26 - 27 October 2022: Fifth ASEAN Inclusive Business Summit

The Ministry of Industry, Science, Technology & Innovation, Government of Cambodia, the United Nations ESCAP, the Inclusive Business Action Network (iBAN), the Organisation for Economic Co-operation and Development (OECD) and OXFAM will co-organise the Fifth ASEAN Inclusive Business Summit in a hybrid format, in Siem Reap, Cambodia. The Summit will focus on supporting the implementation of the Guidelines for the Promotion of Inclusive Business in ASEAN; particularly on policy recommendations, and policy instruments and mechanisms of IB investment incentives. The discussions include reviewing the progress made in promoting a better enabling environment for IB enabling environment (IBee) in ASEAN countries and globally; discussing opportunities for collaborating on policy promotion instruments such as business coaching and accreditation; exploring means to encourage women economic empowerment and climate adaptation through inclusive business. 


30 September 2022: Cross-border e-payments: Side event at the Third Ministerial Conference on Regional Economic Cooperation and Integration

6-7 October 2022: Sixth North and Central Asian Multistakeholder Forum on Implementation of the Sustainable Development Goals

ESCAP is organizing the Sixth North and Central Asia Multi-Stakeholder Forum on Implementation of the Sustainable Development Goals. The Forum is a unique platform for policymakers and other key stakeholders to share subregional perspectives, discuss collaborative measures to address subregional priorities and exchange good practices to achieve the 2030 Agenda for Sustainable Development. Its conclusions and recommendations will feed into the Tenth Asia-Pacific Forum for Sustainable Development (APFSD) of ESCAP and the 2023 UN High-level Political Forum on Sustainable Development (HLPF). Upcoming ESCAP activities and events

17 October 2022: 1st Annual Forum on Connectivity: Side Event to the 22nd Meeting of the GTI Consultative Commission

The 1st Annual Forum on Connectivity will be utilized as a platform for sectoral dialogues in line with the theme of the 22nd Meeting of the Consultative Commission (CC) chaired by Mongolia, "Framework for Agriculture Development and Food Security in the Greater Tumen Region". In particular, the Forum will aim to: 1) inform of the agriculture and food security landscape of GTI member countries; 2) share global developments and practices in addressing food security challenges and promoting agriculture development;3) encourage knowledge sharing and regional cooperation on agriculture development, including through digital transformation and innovation; and 4) highlight key cross-sectoral linkages supporting food security and agriculture development. 18-19 October 2022: Sustainable Connectivity in East and North-East Asia: Technical Consultation Workshop on Dry Ports Development

ESCAP, in coordination with the Investment Research Center of the Ministry of Foreign Affairs, Mongolia, conducted a technical assessment of dry ports identified by Mongolia in the Agreement (i.e., Altanbulag, Sainshand, Ulaanbaatar, Zamyn-Uud and Choibalsa) as well as possible new dry ports locations. Following the assessment study, a technical consultation workshop will be jointly organized by ESCAP and the Investment Research Center. The workshop aims to: 1) consult with officials and stakeholders involved in dry ports development in Mongolia on the findings of the study towards identifying priority areas for possible technical assistance and capacity building; 2) update parties involved in the China-Mongolia-Russia Economic Corridor Program on dry ports development and other projects; and 3) exchange information on dry ports development towards identifying possible areas for collaborations. 19-21 October 2022: High-level Intergovernmental Meeting on the Final Review of the Asian and Pacific Decade of Persons with Disabilities, 2013-2022

As the Asian and Pacific Decade of Persons with Disabilities concludes in 2022, the Economic and Social Commission for Asia and the Pacific (ESCAP) is organizing the High-level Intergovernmental Meeting on the Final Review of the Asian and Pacific Decade of Persons with Disabilities, 2013-2022, pursuant to ESCAP resolution 69/13. The meeting will be hosted by the Government of Indonesia, in Jakarta and online from 19 to 21 October 2022. The meeting will review progress and achievements made in the Decade (2013-2022), foster consensus on new strategic directions, and renew commitments by ESCAP members and associate members to disability rights and disability-inclusive development in the Asia-Pacific region, leading up to the achievement of the 2030 Agenda for Sustainable Development. 20 October 2022: Capacity Building Workshop on Strengthening Digital Connectivity Infrastructure and Internet Traffic Management in the Pacific

1 November 2022: The 17th Policy Consultation Forum of the Seoul Initiative Network on Green Growth (SINGG)

The Forum provides a platform to discuss best practices and facilitate an exchange of experiences among Member States and strengthen collaborative efforts in responding to climate change and moving forward to carbon neutrality by 2050. 9-10 November 2022: The first Asia-Pacific Digital Ministerial Conference 2022: Shaping Our Common Future and the Asia-Pacific Digital Transformation Forum will be held in Seoul, Republic of Korea, to serve as a prime opportunity to discuss the status, challenges, and pathways to advance digital transformation and to strengthen regional digital cooperation with the ICT and Digital Ministers of the Asia-Pacific region towards building an inclusive digital society and economy. The Ministerial Conference will also consider the adoption of the Seoul Declaration (tentative title) and the endorsement of the Asia-Pacific Information Superhighway Action Plan 2022-2026, as part of the pathways to advancing digital transformation in the Asia-Pacific region.
