#### Call for proposals for side events at APFSD

The 8<sup>th</sup> Asia-Pacific Forum on Sustainable Development (APFSD) will be held in hybrid mode on 23-26 March under the theme *"Sustainable and resilient recovery from the COVID-19 pandemic in Asia and the Pacific"*. Side events to the APFSD can be organized and sponsored by member States, the UN system, other intergovernmental organizations, accredited CSOs or other stakeholders. Held outside the official programme, they provide an opportunity to discuss the theme of the 2021 APFSD *"Sustainable and resilient recovery from the COVID-19 pandemic in Asia and the Pacific"*, or one (or more) of the SDGs under review, or to deepen discussions on Voluntary National Reviews, and to share good practices, identify new and emerging issues, and spread greater awareness of the 2030 Agenda and the SDGs. The fund will support innovative business solutions that address the constraints faced by women enterprises in South and South-East Asia. Eligible applicants who can apply for the Fund include regulated financial institutions, FinTechs, technology institutions, among others. #### 7th Asia-Pacific Trade and Investment Week

The 7th Asia-Pacific Trade and Investment Week was held on 25-29 January 2021. The week included the Sixth Meeting of the Interim Intergovernmental Steering Group on Cross-border Paperless Trade Facilitation; the seventh session of the Committee on Trade and Investment; demonstration of the Trade Intelligence and Negotiation Adviser (TINA 3.0), developed by the ESCAP secretariat to assist member states in negotiating regional and bilateral trade agreements, of a Regional Integration and Value Chain Analyzer (RIVA) tool, and of an Online Readiness Assessment Guide for Cross-border Paperless Trade; a webinar on Enhancing Trade Information Portals, a webinar on Asia-Pacific LDCs' graduation, trade and pandemic; and an ARTNET Lecture series on Trade and Trade Policy during the Pandemic. ESCAP and the Small Enterprise Assistance Funds (SEAF) announced the successful launch and first close of the SEAF Women's Economic Empowerment Fund (SWEEF) in January. In early 2020 ESCAP and SEAF formalized a <u>partnership</u> to catalyze women's entrepreneurship through gender lens impact investing in Asia. #### **Upcoming ESCAP events**

23-24 February 2021: 10th meeting of the Asia-Pacific Foreign Direct Investment (FDI) Network

The Network was established in 2011 as a mechanism for knowledge sharing among FDI policy makers from Least Developed and Landlocked Developing Countries of the Asia-Pacific region and was expanded in 2015 to include all ESCAP member and associate member States. Each year, the network meets to discuss topical FDI issues and increase their knowledge through exchange of experiences and interaction with FDI experts. ## 1 March 2021: First Meeting of the Asia-Pacific MSME Policymakers Network: MSMEs and the digital economy

ESCAP will convene the first meeting of a new network of policymakers that brings together government officials with specific responsibilities for MSME policy. This network will be oriented toward sharing experiences of the MSME policies being implemented in the region, bringing attention to the successes, and finding ways to enhance the vitality of this important sector. The inaugural meeting of the network will discuss the current state of MSME participation in the digital economy. While the digital economy has revolutionized some aspects of commerce, many MSMEs still have trouble fully utilizing all the benefits that new e-commerce, fintech, and trade technologies can bring.

# 2 March 2021: ASEAN Regional Policy Dialogue (ARPD): the role of Competition Policy in supporting MSMEs economic recovery in the post COVID19 crisis

ESCAP, UNCTAD and ASEAN are partnering to hold a regional dialogue on the role of competition policy in supporting MSMEs. With the COVID-19 pandemic causing damage to MSMEs across many sectors, some industries are at risk of losing their diversity as businesses fail or are acquired by competitors. Competition authorities from ASEAN member states, as well as representatives of MSME policymaking bodies, will come together to discuss the implications of the crisis for competition policy and how policies should support MSMEs in the recovery.

#### 1-5 March 2021: Virtual Training on Digital Technologies for Disaster Risk Management

This training which is based on the APCICT Academy Module on "ICT for Disaster Risk Management", aims to equip policymakers in South and South-West Asia with a practical skillset to leverage ICT tools and applications for disaster mitigation, prevention, preparedness, response and recovery. It is organized by APCICT-ESCAP in collaboration Geoinformatics Center (GIC) of the Asian Institute of Technology (AIT) and ITC-University of Twente, and held online.
