## **IN FOCUS**

9<sup>th</sup> The Asia-Pacific **Trade** Facilitation Forum and other trade facilitation side events were organized by ADB, ESCAP and India in cooperation with CII, OECD, UNCTAD, WTO and many other organizations in September 2019 in New Delhi, India. Organized under the theme of "Digital and Sustainable Facilitation for Trade Regional Prosperity", the Forum was attended participants from 270 countries. ## **NEWS**

The Philippines acceded to the Framework Agreement on Facilitation of Cross-border Paperless trade in Asia-Pacific on 23 December 2019, the first in ASEAN to do so. The UN treaty is an inclusive instrument accessible to countries at all levels of development and to help them develop their capacity to engage in cross-border paperless trade.

ADB and ESCAP released the Asia-Pacific Trade Facilitation Report 2019: Bridging Trade Finance Gaps through Technology. The report features a special chapter on how trade finance gaps can be bridged by technology, highlighting the policies and actions required to make this happen.

Regional Organizations Cooperation Mechanism for Trade Facilitation (ROC-TF) Meeting, 16 September 2019, New Delhi, India



The 5th ROC-TF meeting took place on 16 September, back to back with the 9th APTFF. Representatives from ADB, APEC, ITC, OCO, PIF, STDF, UNECE, UNCTAD, UPU, World Bank, WCO and WTO participated and shared their trade facilitation initiatives and related action plans. This led to discussions on opportunities and modalities to improve inter-regional and subregional cooperation on trade facilitation. The ROC-TF is a cooperation mechanism between the subregional, regional, United Nations and other international organizations involved in trade

facilitation activities in the Asia and Pacific region. The overall goal of the mechanism is to facilitate the exchange of information, identify synergies and promote collaboration for effective implementation of trade facilitation initiatives.

The 9th Asia-Pacific Trade Facilitation Forum (APTFF) was organized by the United Nations Economic and Social Commission for Asia and the Pacific (ESCAP) and the Asian Development Bank (ADB), in collaboration with the Ministry of Commerce, India and Confederation of Indian Industry (CII).

The theme of APTFF 2019 was "Digital and Sustainable Trade Facilitation for Regional Prosperity" and brought together about 270 participants from 42 countries. As part of the opening session of the Forum, ADB and ESCAP launched the Asia-Pacific Trade Facilitation

Report 2019. Several capacity building side events were organized, for example, a joint ADB-OECD-ESCAP side event on enabling SMEs access to global value chains.


## 3rd session of the Coordination Council on the "Single Window", 23 November 2019, Moscow, Russia

## Readiness assessments for cross-border paperless trade conducted in 8 countries



ESCAP supported Armenia, Bangladesh, Cambodia, Mongolia, Myanmar, Nepal, Timor-Leste and Uzbekistan in carrying out readiness assessments for cross-border paperless trade and organizing national consultations on facilitating cross-border paperless trade as part of implementing the projects funded by the Government of China and the Enhanced Integrated Framework (EIF). This included completing the legal and technical readiness assessment checklists, developed by the Steering Group and its working groups, and developing draft action plans during national consultations. Building on lessons learned, ESCAP and United Nations Commission on International Trade Law (UNCITRAL) have jointly started developing an online support platform to facilitate self-assessments. In addition, the Government of China further funded a follow-up Phase II project, which will focus on the development of national policy frameworks for cross-

border paperless trade and the conduct of a feasibility and scoping study on the electronic exchange of traderelated data and documents between Bangladesh, China, Lao People's Democratic Republic, Myanmar, Thailand, and other relevant South Asian economies between 2020 and 2021.

## The STDF ePhyto project won an Innovation Award



The STDF ePhyto project won a Trade Facilitation Innovation Award at the APTFF 2019. In addition, under the STDF, an SPS e-Cert Advisory Group is being set up to drive global collaboration on electronic SPS certification. The first electronic meeting of this Group will be held in March 2020.

## New technologies to improve SPS management and agricultural production

The STDF is currently using new technologies to improve SPS management and agricultural production. The P-tracker, a customizable smartphone app for plant pest field surveillance developed by the Australian Department of Agriculture and Water resources is currently being used in the STDF project to improve pest surveillance in over seven countries in Asia-Pacific region (<a href="https://www.standardsfacility.org/PG-432">https://www.standardsfacility.org/PG-432</a>). This project addresses the inconsistent approach to pest surveillance in the Asia-Pacific region and the poor standard of reporting of surveillance outcomes.

# The 4th Postal Operational Readiness for E-commerce (ORE) workshop, 4–8 November 2019, Bangkok, Thailand

As part of implemenation of the Istanbul World Postal Strategy to improve the interoperability of network infrastructure, the UPU launched the operational readiness for e-commerce (ORE) project for the 2017-2020 cycle. The workshop was for ORE country project managers and their team members responsible for transport. The objectives of workshop include: (i) Follow-up of ORE roadmap and action plan to evaluate the progress made and the way forward; (ii) Better understanding of IQRS reports: E2E reliability, Dashboards, Dashboards by month, Transport reports, customs reports, compliance reports; (iii) Enhance skills of participants on usage of IT tools (IPS, CDS). The workshop was attended by 42 postal representatives of the Asia region.

# Disaster Risk Management Regional Training Workshop for Asia and Pacific countries, 11–13 November 2019, Bangkok, Thailand

With the assistance of several organizations (including UNESAP), UPU published a guide to disaster risk management for the postal sector in 2015. This comprehensive guide addresses all types of hazards and touches upon every aspect of disaster risk management (DRM). By attending the workshop, participants had acquired a basic understanding of DRM and practical knowledge about DRM planning and training, and to use the knowledge acquired to promote DRM activities and develop disaster resilient postal services once back in their countries. The workshop was attended by 22 postal representatives of the Asia Pacific region.

## **Highlights from ADB-ESCAP ASIA-PACIFIC TRADE FACILITATION REPORT 2019**

Bridging trade finance gaps through technology

International trade is included as an important Means of Implementation of the 2030 Agenda for Sustainable Development, Trade facilitation, or making trade procedures more efficient to ensure that engaging in licit trade is easier and cheaper for all, has been acknowledged as one of the keys to ensuring that trade contributes to addressing the social, economic and environmental dimensions of sustainable development in a more balanced way.

Trade costs in Asia and the Pacific remain high despite having declined modestly and vary widely across subregions. The ESCAP-World Bank Trade Cost Database shows that the cost of trading goods is highest among the Pacific island developing economies, followed by the Russian Federation and Central Asia, and South Asian economies. Both Central Asia and the Pacific have, however, made progress in reducing trade costs with East and Southeast Asia. East Asia shows the lowest trade costs in the region, followed by the Association of Southeast Asian Nations (ASEAN) middle-income members.




Figure 1: Overall implementation of trade facilitation measures in 46 Asia-Pacific countries

The 2019 Global Survey on Digital and Sustainable Trade Facilitation shows significant progress toward streamlining trade procedures in the region. The average implementation rate of trade facilitation measures in Asia and the Pacific jumped by 10 percentage points between 2017 and 2019, to nearly 60%. The Russian Federation and Central Asian countries made the most progress, as implementation rates increased by more than 13 percentage points to 65.6% in 2019. The Pacific islands made the least progress. Implementation in 2019 varies by subregional group. After Australia and New Zealand, the highest average rate is found in East Asia (79.3%), followed by South-East Asia and Timor-Leste (70.3%), the Russian Federation and Central Asia (65.6%), and South Asia, Iran, and Turkey (55.4%). The Pacific lags at 35.5% (see Figure 1).

Implementation also varies across groups of measures. Transparency measures, along with many of the general trade facilitation measures featured in the World Trade Organization Trade Facilitation Agreement (WTO TFA) are well implemented across the region, averaging implementation rates close to 80%. In contrast, cross-border

paperless trade measures such as *electronic exchange of certificates of origin or of sanitary or phytosanitary certificates* have been initiated in less than 40% of the economies of the region, often only on a pilot basis. Measures targeted at agricultural trade facilitation have a regional average implementation rate of nearly 50%. However, low average implementation rates for small and medium-sized enterprises (SMEs, 36%) and womenowned firms (23%) show that very few countries have customized trade facilitation measures. Trade finance facilitation measures, such as the provision of trade finance through electronic single window systems, are found to have been considered by only a few countries, and rarely implemented (see Figure 1).

## **Impact of Trade Facilitation on Trade Costs**

A simulation analysis demonstrates that implementation of trade facilitation measures that emphasizes trade digitalization, combined with improved maritime connectivity and access to credit issues, can reduce trade costs significantly. Simulated implementation was tested for different packages of trade facilitation measures. As shown in table 1, implementation of binding and non-binding WTO TFA measures reduces trade costs, on average, by 5% under a partial implementation scenario, and by 9% under the more ambitious full implementation scenario. Under a WTO TFA+ scenario where digital trade facilitation measures not specifically included in the WTO TFA are implemented, the average trade cost across countries declines by almost 17%.

While continuous implementation of TFA-related measures is important, economies in Asia and the Pacific need to move gradually toward digital trade facilitation. The 2019 Survey confirms that most countries in the region are engaged in implementing measures to improve transparency, enhance interagency coordination and cooperation, and streamline the fees and formalities associated with trade. However, implementation of bilateral and/or subregional paperless trade systems remains mostly at the pilot stage. The Framework Agreement on Facilitation of Cross-Border Paperless Trade in Asia and the Pacific, a United Nations treaty developed by more than 25 countries at different stages of development, provides the inclusive and flexible intergovernmental platform needed to accelerate progress, while leaving no one behind.

## **Bridging Trade Finance Gaps through Technology**

Trade finance supports international trade and more inclusive growth. International trade and policy reforms to lower barriers to trade are widely known to benefit inclusive growth. Access to trade finance allows businesses to fund operating costs and deal with various risks, whether commercial, exchange rate, transportation, or political. These risks are addressed through different instruments such as letters of credit, bank guarantees, and export credit insurance. While advanced economies typically have financial systems that provide widespread access to funding, developing economies find access to finance far more difficult— particularly for SMEs.

Unmet demand for trade finance is persistently large. An indicative measure of rejected trade finance applications shows a gap of about \$1.4 trillion—\$1.6 trillion, or around 8%—10% of world merchandise trade. Around half of global trade finance proposals originate from Asia and the Pacific, while 40% of rejected applications come from the region. SMEs are most affected as they tend to have higher rejection rates than larger firms. Banks have higher transaction and information costs when dealing with smaller companies, including anti-money-laundering/know-your-customer requirements and the low credit ratings of issuing banks and importers. High costs also make it unprofitable for small businesses to use trade finance instruments such as letters of credit.

There are three main challenges in providing trade finance. First, the continued use of paper means that documentary transactions in trade finance are prone to costly delays and errors. Letters of credit, for instance, may involve examination and validation of 10 to 20 documents involving more than 20 parties in information exchange and transmission. Second, financial institutions are required to conduct significant due diligence, which raises the cost of supplying trade financing. Third, while banks require knowledge of their clients to mitigate information asymmetry, this may pose significant hurdles in SMEs accessing finance.

Digitalization and automation may help address some long-standing issues in trade finance, such as high transaction processing costs and costly know-your-customer procedures. SMEs are usually burdened by high interest rates and collateral requirements, while banks are discouraged by the high cost of regulatory compliance. Technologies can help cut costs and facilitate transactions by eliminating manual documentation and enable accumulated digital information on SME profiles for lenders to assess risk. E-commerce platforms and cloud-based invoicing, for example, allow direct transactions among smaller firms with reduced costs. Blockchain technology and artificial intelligence can facilitate due diligence and payments for SMEs that have difficulty in accessing bank credit. Such technologies utilize big data and alternate credit information that can enable more efficient know-your-customer compliance and due diligence. These technologies offer solutions that substantially improve efficiencies at various stages of international trade and therefore draw more SMEs into the system.

Despite its rapid expansion, digitalization and fintech in trade finance still need to overcome major challenges. Digitalization is far from complete and implementation costs are one of its biggest issues. Blockchain technology is not entirely free of the risks related to transparency, cybersecurity, and operations, and can pose regulatory challenges. Fragmented digitalization can also create problems with digital implementation, making it difficult to be compatible and interoperable with other parties' systems.






# CAREC Corridor Performance Measurement and Monitoring Annual Report 2018, November 2019




# Climate Change Impacts and Adaptation for Coastal Transport Infrastructure: A Compilation of Policies and Practices, January2019






# The National Trade Facilitation Roadmap for Exports Enhancement and Diversification of the Republic of Tajikistan 2019 – 2024, December 2019




# Trade Facilitation Terms: an English-Russian-Chinese Glossary, December 2019





This report presents the results of the third UN Global Survey on Digital and Sustainable Trade Facilitation, undertaken jointly by the five United Nations Regional Commissions for Africa (ECA), Europe (ECE), Asia and the Pacific (ESCAP), Latin America and the Caribbean (ECLAC) and West Asia (ESCWA).

The survey covers 46 countries in Asia and the Pacific, consisting of a questionnaire that includes 53 trade facilitation measures under four groups: "General Trade Facilitation", "Digital Trade Facilitation", "Sustainable Trade Facilitation" and "Trade Finance".

The results of the survey will enable countries and development partners to better understand and monitor progress on trade facilitation, support evidence-based public policies, share best practices and identify capacity building and technical assistance needs. ## Global Economic Prospects, January 2020 : Slow Growth, Policy Challenges

Global growth is projected to reach 2.5 percent in 2020, slightly faster than the post-crisis low registered last year. While growth could be stronger if reduced trade tensions lead to a sustained reduction in uncertainty, the balance of risks to the outlook is to the downside. Growth in emerging market and developing economies (EMDEs) is also expected to remain subdued, continuing a decade of disappointing outcomes. A steep and widespread productivity growth slowdown has been underway in EMDEs since the global financial crisis, despite the largest, fastest, and most broad-based accumulation of debt since the 1970s. In addition, many EMDEs, including low-income countries, face the challenge of phasing out price controls that impose heavy fiscal burdens and dampen

investment. These circumstances add urgency to the need to implement measures to rebuild macroeconomic policy space and to undertake reforms to rekindle productivity growth. These efforts need to be supplemented by policies to promote inclusive long-term growth and accelerate poverty alleviation.

## PH accedes to UN treaty on paperless trade across Asia-Pacific. 27 December 2019

The Philippines was the first in ASEAN to approve a UN treaty facilitating paperless trade across the region, the UN Economic and Social Commission for Asia and the Pacific (UNESCAP) said on Thursday.

Thus far in Southeast Asia, only the Philippines had acceded to the United Nation's Framework Agreement on Facilitation of Cross-border Paperless Trade in Asia and the Pacific, UNESCAP said on a social media post. UNESCAP said the Philippines acceded to the agreement on Monday, Dec 23.

The framework agreement, which had been deposited with the UN secretary general in New York, is aimed at "accelerating the implementation of digital trade facilitation measures for trade and development," UNESCAP said.

"Designed as an inclusive instrument accessible to countries at all levels of development to develop their capacity to engage in cross-border paperless trade, the final treaty text was adopted by the [Unescap] in May 2016," it explained.

"Trade cost reductions expected from full implementation of cross-border paperless trade are estimated at 10-30 percent of existing transactions costs, depending on the current state of paperless trade development in the participating countries. Significant benefits in terms of trade compliance are also expected," UNESCAP said. INQ

## DCSA Establishes Track and Trace Standards for the Global Container Shipping Industry, 29 January 2020

The Digital Container Shipping Association (DCSA), a neutral, non-profit group established to further digitalisation of container shipping through technology standards, today in conjunction with its nine member carriers, published a common set of processes, as well as data and interface standards for Track and Trace (T&T). The standards can be implemented by carriers. shippers and third parties to enable cross-carrier shipment tracking. This is the first of many initiatives to be put forth by DCSA to transform inefficient practices and accelerate digitalisation through a unified industry effort. The DCSA T&T standard comprises an information model and interface standards that can be freely downloaded from the DCSA website. The data model ensures track and trace data definitions are consistent for all users, leveraging any system. These

definitions are based on the Industry Blueprint, published by DCSA and its carrier members in 2019, which established a consistent vocabulary and proposed a common set of industry processes. The T&T standards are aligned with the UN/CEFACT (United Nations Centre for Trade Facilitation and Electronic Business) standards to provide a global industry framework that preserves existing investments and streamlines communication among all supply chain participants.
