Dr. Nagesh Kumar, Director of UNESCAP SSWA Office moves on to a new position



After 12 years of dedicated service at the UNESCAP, Dr. Nagesh Kumar, Director and Head of UNESCAP South and South-West Asia Office, based in New Delhi has decided to take an early retirement from United Nations to head the Institute for Studies in Industrial Development (ISID), a New Delhi based public-funded think-tank.



With the retirement of Mr. Nagesh Kumar on 30 April 2021, Mr. Adnan Aliani, Director, Strategy and Programme Management Division, UNESCAP, Bangkok has been designated with additional responsibility as the Officer-in-Charge of UNESCAP Subregional Office for South and South-West Asia Office, New Delhi with effect from 1 May 2021.

1. South Asian Countries participate in the 77th session of the UNESCAP



Bangkok, Thailand, 29 April 2021. Policymakers from more than 50 Asia and the Pacific countries participated in the 77th Commission Session of the UNESCAP (26-29 April 2021) under the theme "Building back better from crises through regional cooperation in Asia and the Pacific." Governments called for a 'whole-of-society" response to COVID-19 and encouraged coordinated action across the region to mitigate the economic and social devastation brought on by the pandemic. Delegates underlined the importance of ensuring universal and equitable access to vaccines, investing in social protection systems that promote access to essential services and decent jobs, particularly to meet the health and social care needs of the most vulnerable populations, and promoting the continued flow of essential goods and services. Ms. Armida Salsiah Alisjahbana, United Nations Under-Secretary-General and Executive Secretary of ESCAP, in her closing remarks to the Commission's 77th session stated that "we are committed to supporting governments to building back

better from the COVID-19 pandemic through inclusive, resilient and sustainable recovery strategies. It is my utmost hope that the resolution on regional cooperation to build back better from crises in Asia and the Pacific will further mainstream our response to COVID-19."

During the general debate, special statements were delivered by many prominent leaders from South Asia, which included statements by H.E. Mr. Mohammad Ashraf Ghani, President of the Islamic Republic of Afghanistan; H.E. Ms. Sheikh Hasina, Prime Minister of the People's Republic of Bangladesh; H.E. Dr. Lotay Tshering, Prime Minister of the Kingdom of Bhutan; H.E. Mr. Imran Khan, Prime Minister of the Islamic Republic of Pakistan; and H.E. Mr. Mahinda Rajapaksa, Prime Minister of the Democratic Socialist Republic of Sri Lanka. More than 500 delegates from 52 of the Commission's 62 members and associate members attended the session via a virtual platform.

Bangkok, Thailand, 27 April 2021. A strategic dialogue on "Sustainable Graduation in the Challenging Time: Perspectives from Bangladesh and the Region" was hosted by the Government of Bangladesh in association with UNESCAP, UNOHRLLS and WTO on the sidelines of the 77th Session of UNESCAP. The focus of discussion was to discuss International Support Measures (ISMs) needed for the countries in the region for their sustainable development amidst this unprecedented challenging time. The welcome remarks to the virtual session were given by Ambassador H. E. Mr. Mohammed Abdul Hye, Permanent Representative of Bangladesh to ESCAP, followed by a statement by Ms. Armida Salsiah Alisjahbana, UN under Secretary General & ESCAP Executive Secretary and a keynote presentation by Ms. Zuena Aziz, Principal Coordinator (SDG Affairs), Prime Minister's Office, Bangladesh. The panel discussion was moderated by Dr. Nagesh Kumar, Director of UNESCAP-SSWA Office and had active participation of high-level representatives and officials from different countries, development partners, senior officials from the UN, major



3. Launch of the Theme Study "Beyond the Pandemic: Building Back Better from Crises in Asia and the Pacific" during the 77th session of UNESCAP





Bangkok, Thailand, 20 April 2021. UNESCAP launched the Theme Study for the 77th Session of the Economic and Social Commission for Asia and the Pacific, which analyses the socio-economic effects of the pandemic, takes stock of action taken so far, and sets out a policy agenda for building back better. Dr Armida Salsiah Alisjahbana, Under-Secretary-General of the United Nations and Executive Secretary of ESCAP in her opening remarks stated that "the commitment to build back better has become even more urgent given the scale of the task ahead. The 77th Commission session Beyond the Pandemic report identifies fault lines in the region's societies and economies that COVID-19 was quick to expose". This was followed by a breakout session of South and South-West Asia region where a subregional perspective was presented by Dr. Nagesh Kumar, Director UNESCAP South and South-West Asia Office, New Delhi. Leading think tank representatives from South Asia expressed their views in a panel discussion highlighting priority areas and perspectives for building back better with focus on sub-regional cooperation. The panelists included Dr. Abid Suleri, Executive Director, Sustainable Development Policy Institute (SDPI), Pakistan; Prof. Sachin Chaturvedi, Director-General, Research and Information System for Developing Countries (RIS), India; Dr. Fahmida Khatun, Executive Director, Centre for Policy Dialogue (CPD), Bangladesh; Dr. Posh Raj Pandey, Chairman, South Asia Watch on Trade, Economics, and Environment (SAWTEE), Nepal; and Dr. Ganga Tilakaratna, Research Fellow, Institute of Policy Studies (IPS) of Sri Lanka.

5. Online training courses on e-commerce and digital marketing conducted for women entrepreneurs of South Asia under the UNESCAP-EIF project




New Delhi, India, 9 April 2021. UNESCAP, in partnership with Enhanced Integrated Framework, Geneva, South Asian Network on SDGs (SANS) and South Asia Women Development Forum (SAWDF) held two online training courses out of the series of trainings on e-commerce planned for women entrepreneurs in April and June 21. The trainings were conducted with an aim of enhancing the knowledge and capacity of MSME-led women entrepreneurs from 10 countries of South and South-West Asia to use digital marketing tools and e-commerce platforms to expand their business exports and participate in local, regional and global supply chains. The sessions covered topics on how to use social media platforms, use e-commerce and digital marketing to promote business, registering with varied marketplaces, online rural marketing, along with a dedicated hands-on sessions on registering and creating products and services catalogues as well as uploading the profile as an entrepreneur at e-market place including at training platform https://www.unescap.wesellonline.org/. A total of more than 500 women entrepreneurs joined these trainings online. The training also facilitated how to market the products and services as dedicated sessions were also allocated for participants to speak and displayed their products and services during the networking sessions.

6. Subregional launch of the midterm Civil Registration and Vital Statistics (CRVS) Report highlights the challenges faced in South and South-West Asia region



New Delhi, India, 29 June 2021. The Asia-Pacific region has reached the midpoint of the Asian and Pacific Civil Registration and Vital Statistics (CRVS) Decade (2015-2024) and a regional level launch of the midterm CRVS report was done on 28 July 2020. This was followed by a virtual subregional launch of the midterm Civil Registration and Vital Statistics (CRVS) report on 29 May 2021 which highlighted the challenges faced in South and South-West Asia, presented key findings and sharing of experiences on country progress towards establishing universal CRVS systems. The virtual launch had participation from national statistical organizations, partner agencies, development partners, civil society, and other relevant stakeholders from South and South-West Asian subregion. In her opening remarks, Ms. Armida Salsiah Alisjahbana, Under-Secretary-General of the United Nations and Executive Secretary of ESCAP, highlighted that to ensure no one is left behind and to reach the furthest behind, robust CRVS systems are fundamental to advance the achievement of SDGs across Asia-Pacific. Mr. Hasibullah Mowahed, Deputy Director General for Statistics of National Statistics and Information Authority of Afghanistan and Vice-Chair of the Regional Steering Group for CRVS in Asia-Pacific delivered the welcome remarks. In their opening remarks, Mr. George Laryea-Adjei, UNICEF Regional Director for South Asia, Dr. Pem Namgyal, Director Progamme Management, WHO, South-East Asia Regional Office, and Dr. Arash Rashidian, Director of Science, Information, and Dissemination, Eastern Mediterranean Regional Office, WHO, highlighted the urgent need for universal civil registration of births, deaths and causes of death in South and South-West Asian countries. A youth representative, Ms. Nimmu from Sri Lanka shared her experiences on consultations with youth and children on CRVS. Following this, Mr. Rajan Sudesh Ratna, Economics Officer, ESCAP subregional office of South and South-West Asia, presented the key findings of the report as well as the subregional perspectives and country insights. He highlighted the criticality of universal and robust CRVS systems in the context of the COVID-19 pandemic and for monitoring the SDGs in the subregion. Dr. Pandup Tshering, Hon'ble Secretary, Ministry of Health, Bhutan and Ms. Sandhya Singh, Deputy Registrar General, Office of the Registrar General and Census Commissioner, India shared their country progress in civil registration systems.

Srinivas Tata, Director, Social Development Division, UNESCAP, Bangkok and Ms. Pacita Juan, Past Chairperson, ASEAN Women Entrepreneurs Network (AWEN), Philippines. The speakers spoke on the topic of women entrepreneurship and their organization's responses towards managing the various risk faced by women entrepreneurs including the impact of COVID-19 pandemic. On the second day, Dr. Rajan Sudesh Ratna, Economics Officer, ESCAP sub regional office for South and South-West Asia moderated a panel discussion on the challenges faced during COVID crisis and what innovative or new approaches were adopted by them to be successful. The women entrepreneurs shared their experiences and emphasized on building the businesses on the 3Rs- resilience, response, and reliability.

1. Dialogue on leveraging PLI scheme to push large scale manufacturing in India

New Delhi, India, 17 June 2021. Trade Promotion Council of India organized a webinar on "Leveraging PLI scheme to push large scale manufacturing in India" in reference to the Government of India's announcement of an outlay of Rs 1.97 lakh crore for the Production-Linked Incentive (PLI) scheme for 13 identified sectors in their 2021-2022 budget speech. The scheme that aims to boost domestic manufacturing under the government's Atmanirbhar Bharat initiative, was introduced in March last year and is expected to result in a minimum production worth more than \$500 billion in five years, according to Indian Commerce Ministry. The scheme provides incentives to companies for enhancing their domestic manufacturing apart from focusing on reducing import bills and improving the cost competitiveness of local goods. Dr. Rajan Sudesh Ratna, Economics Officer, ESCAP sub regional office for South and South-West Asia was one of the panelists to the discussion. Dr. Ratna in his remarks shared his perspectives on how the PLI scheme can help Indian industry to integrate with the global standards. He also highlighted the significance of adopting to the international standards in getting into international markets as well as regional or global supply



chains. He also shared the experiences of ASEAN and SAARC in harmonizing standards and promoting the intra-regional and global trade and investment flows.

IV. Highlights of the 77th Commission Session - Country Statements



Islamic Republic of Afghanistan

In his video message, H.E. Mr. Mohammad Ashraf Ghani President of the Islamic Republic of Afghanistan highlighted that the COVID-19 pandemic has exacerbated inequalities and exposed structural weaknesses in our global system and therefore the interrelated challenges relating to social protection, stimulation of sustainable recovery, strengthening of connectivity and supply chains and focus on climate change must be addressed. To build back better, greener, and more equal, robust, and connected, including by ensuring universal and equitable access to vaccines as a global public good is essential; without which the SDGs cannot be met. He stressed that regional connectivity and integration is essential for recovery and highlighted the support that Afghanistan got from various donors and countries which helped control the effect of pandemic. Highlighting the efforts of Afghanistan through investing on people, expanding social protection systems, climate change adaptation and resilient programmes, digitalization, promotion of education, he stated that government is committed to resolving armed conflicts and working for a peace process to a political settlement. He expressed the willingness of government towards stakeholder governance and stakeholder economic development that would result in integration of systems of state-building, market building, peace-building, and regional connectivity and prosperity.

In the country statement, Afghanistan highlighted that due to COVID-19 pandemic, the education sector suffered due to lack of access to digital technology and that the prices of basic necessities saw a rise depriving its citizens. A whole-of-society and whole-of-planet approach was prescribed to address the current challenge; with greater emphasis on health care, facilitating trade and more effective use of technology and digitalization. It was stated that the government is working hard to establish a system of e-governance and making efforts to administer vaccines to all the citizens.



Bangladesh

In a video message, Her Excellency Ms. Sheikh Hasina, Prime Minister of the People's Republic of Bangladesh, noted the devastating effect of COVID-19 and informed that Bangladesh had also announced a stimulus package of USD 14.6 billion, which is around 4.4% of GDP, for widening social protection, retaining jobs and bolstering the economy. She stated that the latest Five Year Plan has included strategies for recovery from COVID-19 as well as smooth and sustainable graduation from LDC. She opined that regional cooperation is the most viable option for shared prosperity and highlighted that Bangladesh is participating in many connectivity related work including those initiated by UNESCAP. She recommended that in order to build back better, development approach should be more inclusive, resilient and environment friendly, and that a seamless connectivity covering trade, transport, energy and ICT, and science and technology need to be established.

In the country statement Bangladesh noted that the present pandemic cannot be controlled without a more resilient regional public health system and thus establishing and strengthening regional integrated disease surveillance networks, establishing coordinated mechanisms to slow the spread of viruses across borders, harmonizing health protocols and standards among countries would be essential. He also suggested for exploring pooled procurement mechanisms for vaccines can make a lot of difference in pandemic management.

Bangladesh informed that it is celebrating the Golden Jubilee of it's independence as well as the birth anniversary of the father of the nation, Sheikh Mujibir Rahman this year. Bangladesh was one of the fastest growing economy in the Asia- Pacific region, but COVID-19 put a negative impact on employment, income, business, investment, international trade and on almost all other aspects of life in their country. To combat the adversities of COVID-19, the Government of Bangladesh has dispersed additional allowances to persons under social safety net and disability identification survey. Further, Bangladesh has revoked the loan repay-ability under rural social service programme and provided initial assistance with the same.



His Excellency Dr. Lotay Tshering, MBBS, MD, Prime Minister of the Kingdom of Bhutan in his video message acknowledged the support given to Bhutan by UNESCAP. He pointed out various challenges faced by Bhutan, including the lack of capacity to build simple items for protection from COVID and their shortages whenever the global need is acute. He informed that almost 95% of the eligible population has been vaccinated and since Government has been investing in the social sector, it does not require to bother about expenses in health and education. He highlighted that the concept of "development with values" could be an integral component of the "new normal" as falling back on basic human values is equally important as advancement in technology.

Bhutan stated in another session that it's GDP is expected to see a negative growth of -6.1%. Bhutan has undertaken several measures to control the pandemic which includes social and welfare protection plans, health infrastructure and first dose of vaccination to entire eligible population which has been done with support of Government of India. Bhutan highlighted that it is working towards smooth and sustainable graduation, despite the fact that it has not met the threshold for the critical economic vulnerability index. It's current twelfth five-year plan will address last mile challenges in all the sectors and ensure that Bhutan's graduation is sustainable and irreversible. However, he noted that countries need to look how the LDCs, LLDCs and Pacific Island Countries can be better prepared to absorb such shocks in future. Bhutan also stressed the need to review smooth transition strategy to ensure that countries graduating from LDC category do not fall back.



India

Recalling the crisis created by the COVID-10, India highlighted the vulnerability it brought to global trade and supply chains and suggested that an inclusive and equitable development through regional cooperation can be useful to build back better. India stated that the Government has announced a series of reforms including a stimulus package of more than 13% of GDP to strengthen the investment climate and to boost its manufacturing activities. India has supplied critical medicines to over 150 countries and providing vaccines to 80 countries and 200,000 doses to UN peacekeepers under its vaccine friendship initiative. To ensure expedition and equitable distribution of vaccines globally, India has called for suspension of IPRs related to COVID-19 vaccines for a period. Further, India has taken a slew of trade facilitation measures that have been instrumental in reducing time and cost of various procedures and compliances. India has encouraged global initiatives including the International Solar Alliance and set up an ambitious renewable energy target of 450 GW by 2030 for SDG on Climate Change and Action.

During the pandemic, a series of steps were taken by the Indian government to protect the disadvantaged sections and to provide support to them. Indian Sign Language Research and Training Centre developed accessible format of important government instructions and guidelines relating to COVID-19 as well as accessible videos which are available on its website and YouTube. A dedicated helpline "Kiran" was also started to provide first line of counselling in response to the increasing mental health issues among people due to the pandemic. India has taken two big steps- Bangladesh Bhutan India motor vehicle agreement and India Myanmar Thailand Tri Lateral highways to improve the regional transport connectivity within neighboring countries.

India emphasized on importance of scaling up investments in science, technology and innovation to mitigate the impact of natural disasters and there is a need to build hazard and risk scenarios for such events. It has set up the BIMSTEC Center for Weather and Climate which chairs the regional integrated multi hazard early warning systems council and hosts the SAARC disaster management center. Indian government has also instituted a annual national award in the name of their illustrious freedom fighter" Netaji Subhash Chandra Bose" and is focusing on fulfilling the Sendai framework for disaster risk reduction commitments

The South Asian subregion from the very beginning has taken several steps to join forces in the fight against COVID-19. The SAARC leaders met on 15th March 2020 to chalk out a strategy to fight the pandemic and set up COVID-19 Emergency Fund in which India has also contributed. India also shared its resources, medicines, PPE, testing equipment and its national experience and best practices through webinars and online courses and IT portals. Under the auspices of BIMSTEC met in June 2020 member states resolved to work together to combat the impact of the pandemic. India appreciated ESCAP's SRO New Delhi for effective collaboration with SAARC and BIMSTEC for providing a platform for exchanging best practices and development experiences. India strongly believes that collective action and strong collaboration principles based on equity and inclusivity will catapult the Asia- Pacific region on the trajectory of rapid and sustainable economic growth and well-being.



Islamic Republic of Iran

The Islamic Republic of Iran highlighted that unified action from all government and nations, in the region and beyond, is needed to overcome the pandemic. Iran stated that for achieving the SDGs and ensure an inclusive and connectivity well established principles of cooperation and multilateralism in international relations is a pre-requisite. Iran shared the challenges it faced in implementing sustainable plans and programmes, development programmes, financing national health programmes including transfers for vaccine purchases and production and other medical equipment. Iran reiterated its commitment to multilateral,

regional and international cooperation aimed at enhancing capacities and building resilience of country and people against disaster and crisis including support to the programmes, activities, and a financial contribution of US \$ 5 million to the Asia and the Pacific Centre for Development of Disaster Information Management (APDIM) as a regional institution of ESCAP. Iran stated that it is actively engaged with ESCAP and its member States covering a range of areas including paperless trade framework, road safety, dry port and triple Asian highways (road, rail and information).



Republic of Maldives

The economy of the Maldives, largely dependent on tourism, came to a grinding halt due to the COVID-19 pandemic leading to a decline of GDP by 29.3%. Many development projects and progress in achieving many SDGs were severely disrupted as attention was diverted to tackling health and social crisis due to the pandemic. The pandemic also brought further marginalization of vulnerable sections of society, including the migrant workers. Government took several steps to help relocate the migrant workers to better housing including free repatriation of those who wanted. Concessional loan schemes to assist businesses and moratoriums on student and housing loan repayment were also introduced.

With school closures, a significant portion of children were left without access to education due to a lack of access to functioning internet and television, which will have long term implications for these children. Due to the heavy dependence on the tourism sector, Maldives' economy showed highly vulnerability to external shocks. Diversification of the economy is crucial to be more resilient and to build back better. Maldives has opened up the tourism and tourist arrivals are increasing, yet the economy will take long to revive. Maldives is among the top countries in the administration of vaccines. Maldives recognised that regional cooperation is an essential element for building back better. Gaps in health, education, and other social sectors highlighted by the pandemic must be plugged and that lower carbon emissions and structural transformation must be promoted to build a sustainable and resilient economy.



Nepal

In country statement, Nepal pointed out how the disruption of the public health, education, social security system were impacted due to COVID -19 globally, which further exacerbated the vulnerabilities of the poor and the marginalized societies. Due to the multi-dimensional impact of the pandemic, sectors like trade, tourism and transport have been hit the hardest in Nepal while sectors like education, construction, agriculture, manufacturing supply chain, and service desk were severely disrupted. This led to a negative growth in GDP by two percentage points, fall in revenue collection and reduction in capital expenditure. The pandemic has reversed the gains made by Nepal in social development and progress on SDGs and thus has posed challenge to the goal of 'Prosperous Nepal, happy Nepali'. To control the impact of pandemic the Government had to announce nationwide lockdown from March 2020 and impose a ban on domestic and international flights as well as , closure of land border crossing etc. The government joined hands with social organizations to increase public awareness on health protocols, safety, and sanitization. Measures were taken to create infrastructure, financial resources and medical equipment's to strengthen the health system at all levels. Spending on health was increased by government to provide additional insurance coverage, medical supplies and setting up temporary hospitals and quarantine centres. The government facilitated creation of more employment opportunities within the country, particularly, in the agriculture sector and extra funding was provided for the repatriation of Nepali migrant workers abroad facing serious health risks, job loss, and other legal complications. The government also introduced economic relief packages to revive industrial and commercial sectors and widened the scope of social security.



Islamic Republic of Pakistan

His Excellency Mr. Imran Khan, Prime Minister of the Islamic Republic of Pakistan, in his video message stated that the COVID-19 has unleashed an unprecedented global crisis, leading to increased vulnerability and inequality and forcing countries to lag behind in achieving SDGs. He opined that reaching pre-COVID income levels may now take years as well as uneven recovery among the countries and region. International solidarity is needed to ensure no one is left behind and a right mix of national actions, regional and multilateral collaborations need to be taken. He prescribed four key areas to focus:(i) adopt pro poor inclusive policies (ii) anchor peace and development in human rights (iii) model economies on resilient and sustainable grounds

for green growth(iv) mobilise financing for development and address debt issues for developing countries. He informed that Pakistan has shifted its focus from geo-politics to geo-economics and for any win-win outcome multilateralism cooperation and partnerships are important.



Democratic Socialist Republic of Sri Lanka

His Excellency Mr. Mahinda Rajapaksa, Prime Minister of the Democratic Socialist Republic of Sri Lanka, in his video message shared how the country successfully controlled the spread of COVID-19, with a low death rate and high recovery rate through early detection, contact tracing, quarantine and patient treatment. Sri Lanka provided free access to health to the people through public healthcare system. The government repatriated nearly 100,000 Sri Lankans and started the vaccination program in February 2021. The government took immediate measures to promote resilience, building an inclusive recovery from the pandemic through financial support for households and businesses. The Central Bank reduced policy rates and implemented several concessionary refinancing programs.

The Sri Lankan government is committed to achieve its SDG target and formed Inter-ministerial steering for this purpose. Focusing on youth, the decade "2021 to 2030" has been declared as the decade of skill development in the country. Sri Lanka expressed its interest in strengthening regional ties and the need to accelerate South-South cooperation. It believes that UNESCAP should commit itself to bring relevant and responsive and takes measures relating to, assisting small countries with pandemic recovery and vaccination program, encouraging the growth of foreign employment opportunities, promoting ecotourism and health tourism, and encouraging investments into finding markets for emerging nation. Sri Lanka emphasized regional cooperation to build back better from the crisis.


